Sharon Gast via Molly Charles	Principal	<p>Academics:</p> <p>There will not be Spring 2020 MAPS testing.</p> <p>HCS has 100% participation (K-8) in continuous learning plan. Teachers are stressing flexibility and patience to families.</p> <p>Plan is that core subjects will be graded. Specials may or may not.</p> <p>Faith:</p> <p>GRACE wide virtual mass was well received and many families participated. GRACE is working on possibly planning another.</p>

		<p>Football Mania participation was down. Determining why. Declined enrollment? Declined follow through with tuition agreement? New coordinator? We typically raise around \$8k. this year the profit was \$5300.</p> <p>Auction so far has raised \$18k. (Corporate sponsorship) Expenses for far total \$1200. New date for auction is 10/3/21.</p> <p>GRACE assessment: Jaris Briski has reached out to GRACE to see how exactly our assessment will be handled for next school year. We will essentially be missing an entire auction. We do have enough to cover the entire \$55k. (This is unique to other schools.)</p> <p>HCS teachers each received a \$100 GC to location of their choice as a thank you from SAC. Group supported this action. Cost was \$1700.</p> <p>This year we have invested \$16k back into the school.</p>
Old Business		<p>FAI Fest: Will this event now happen in spring to offset financial obligation for families? Group decided that this would be best. Who will chair? Ben Bertram expressed interest in helping plan event. It was proposed to do another golf simulator event.</p>
New Business		<p>TSF fulfillment: It was proposed to “punt” with this. Decided to not overwhelm families at this time. It will be tracked and enforced for next year.</p> <p>Proposed to bring back parent meeting as part of back to school. Requirements and obligations will all be touched on, therefore there will not be any excuses for non-fulfillment of requirements per the tuition agreements.</p> <p>We will need to find a successor for Jaris as treasurer. He may have an individual who is interested.</p>
