**Schedule Modifications:**

- Continuing to limit recess to one class/cohort per zone at aftercare and recess time
- Continue to stagger lunch to one class through line at a time
- Continue to have specials in classrooms or remotely if possible
- School clubs/activities will remain temporarily suspended

**Staffing Modifications:**

- Continue to utilize special teachers, playground supervisors, Brother Jacob Sircy and supportive consultants as classroom teachers/supervisors as necessary

**Safety/Hygiene Modifications:**

- Properly fitted masks worn by all inside and outside of the building with limited exceptions while eating and if staff are in rooms alone
- Continue sanitizing work areas between learning groups
- Strategic spacing/distancing in classrooms
- Continue sanitizing lunch tables between classes - 4 assigned seats/table - tables spaced out
- Weekly communication that if students are not 100% healthy they need to stay home
- Continue door screening (temp checks, health screening questions) for every child upon entry
- Daily documented staff screening (temp checks, health screening questions) every morning upon entry
- Continued max capacity of 2 individuals per bathroom at once
- Continue to follow one-way hallway traffic
- Student lockers spaced every other as possible
- Continued mid day cleaning of high touch areas as necessary

**Other:**

- **0 positive COVID cases among students**

- GRACE Schools are offering an option to return Face to Face OR virtual for our re-entry. Please discuss your desire to move virtual with the site principal on a case by case basis. (This does not include a move to or from GVA prior to November 23rd.)

- Our full school will be taught virtually the weeks of November 30th-December 4th and January 4th-8th to allow families to become aware of close contacts over holiday gatherings/breaks prior to returning to school.
- A COVID Dashboard will be published and updated for our school daily at 3:30pm
- A re-entry student questionnaire will be completed by all parents prior to returning to school. This will be sent to families 24 hours in advance of our return via email and electronic completion will be required before a student may return to the building.
- All students and staff are required to wear a mask. Exemptions will not be approved. If a student is unable to wear a mask, the virtual program is strongly recommended. - Again, properly fitted masks are required. Disposable child sized masks would be available in the office for that child to use until a properly fitting mask is obtained from home
